### What are the features of the Joint-Master Program on Law?

The program has been developed within the framework of joint education and training scheme and will be conducted by Eastern Mediterranean University (EMU) Faculty of Law in collaboration with the Alma Mater Studiorum Bologna University (UniBo) School of Law. The one-year, first level graduate program (without thesis requirements) is titled as "Comparative Legal Systems". This program is unique in legal education and will be of mutual benefit for students of both Institutions. The main objectives of the Joint Master's Degree (LL.M.) are to encourage innovation and internationalization in the field of law and to improve the quality and attraction of the higher Education Area. The program will make a difference, as one of the modern approaches in the field of legal education, by training students from different countries. Both comparative studies and academic cooperation will be encouraged by the Program, which will act as a point of interest for students in receiving diplomas which shall bear the titles of both Universities.

#### What is the scope of the program?

With the collaboration of both Universities, including lecturers of the Bologna University teaching in EMU, the proposed education will have an international dimension on legal studies. Also, the vital point about the international dimension of the program is that prospective students will obtain diploma bearing titles of the two Universities of different countries. This program will present study opportunities in Public and Private Law from a comparative and international perspective. Within this framework, the European Union Law, International Law, Legal Systems and Human Rights will particularly be scrutinized.

#### What are the program admission rules?

The proposed joint Master's program will meet the demands of both national and international students who graduated from law schools (who have LL.B. degree) and other fields of social sciences (such as international relations, political science so forth) as well as those who have degrees in other fields. Applicants are required to possess a bachelor's degree. Candidates not possessing a Bachelor's Degree in Law are required to take two deficiency courses. Applications are accepted twice a year for Fall and Spring semesters.

#### Total number of credits required to obtain a master's degree

According to the EMU Rules and Regulations program with no thesis requirements are; completion of a minimum of 30 credit-hours of at least 10 courses and preparation of a term project.

#### What is the duration of the program?

The maximum duration of study is three semesters.

# Which courses are offered by the EMU Faculty of Law and UniBo School of Law?

All instructional activities and exams shall take place at Eastern Mediterranean University, Famagusta, North Cyprus.

#### What is the total tuition fee?

A typical tuition fee for this program is \$8000 after 50% scholarship. All international students are granted automatic 50% scholarship by EMU.
